Course Description

The history of social housing dates back to the early 20th century. Strongly connected with industrialization, it first started as a voluntary, philanthropic activity in the U.S.A. and Europe. Since then, a variety of policies have emerged in order to ameliorate the living conditions of the working class. Since the first half of the 20th century vulnerable households, slums or insufficient dwellings have been in the center of interest. Today, affordable housing is more than ever a necessity due to multi-level crises that affect numerous countries. As for Greece, social housing started after the Asia Minor Catastrophe in 1922 and the subsequent vast demographic flow of 1.500.000 refugees. After 1954, the Workers Housing Organization provided affordable housing to other segments of the working class. This organization provided also other forms of housing assistance as grants in settlements, loans for purchase and rent subsidies. Unfortunately, during the contemporary financial crisis, the memorandum of the 12th February 2012, determined that the "Workers Housing Organization" had to close. This decision put an end to the social housing sector in Greece. Concerns on the impact of social housing policies raise skepticism on the exclusionary approach of such policies worldwide. As Serge Paugam notes "in contemporary societies, social exclusion policies are simultaneously inevitable and ineffective", putting in the spotlight the marginalization and stigmatization of the target population. From this point of view, this course explores the connection between social housing and social exclusion in USA and E.U, focusing on Greece. In this context, students will familiarize with the ETHOS European typol-ogy for Homelessness and Housing Exclusion. The aim of the course is to help students elaborate critical thinking on social housing and area-based policies. The course is interdisciplinary based on empirical research and literature review, suitable for architects, urban planners and designers, environmentalists, sociologists, economists, public policy makers and social anthropologists. Among the courses' activities are an online survey so as to explore community's outlook on the synergies between social housing and social exclusion, qualitative research methods as focus groups and field work in selected social housing enclaves in Athens. The course provides also the opportunity to familiarize with the basic principles of thematic cartography. All material will be collected during the scheduled field trips.

Learning Goals

This course will primarily teach students to:

- define the variety of forces that shape the built environment
- evaluate the balance between socio-economic and environmental parameters
- recognize the specificities of time and place in relation to urban planning procedures
- identify and interpret the layered or multifaceted sense of place (with the help of international and Greek case studies)
- discover through field work the socio-spatial inequalities that lead to social exclusion
- dissect the causes of the above-mentioned inequalities
- outline the environmental, social, economic and cultural factors that contribute to spatial justice or injustice
- experiment with the ways that urban and regional planning can manage change in complex environments
- deal with multiple scales of planning
- prioritize a variety of urban issues in terms of collective memory
- recommend innovative tools for area-based policies

Course Requirements and Assessment

CYA Attendance Policy

Grading and Evaluation

Your grade for this course will be based on the following distribution:

1st assignment 10%: Working in groups of 2 or 3, students will write an essay of about 1500 words on social housing policies using at least 2 citations so as to support their arguments. A list of suggested topics will be provided.

2nd assignment 10%: For the purposes of the 2nd assignment students will choose an example of sustainable social housing so as to delve into its social, spatial and environmental features. The 2nd assignment includes essay writing of about 1000 words. The 2nd assignment requires individual work. Instructor will provide a list of suggested topics. (paper 6% and presentation 4%)

Midterm 15 %: The topic of the mid-term assignment is "Social Housing in the UK. Contemporary Challenges". After watching the documentary "Dispossession: The Great Social Housing Swindle", referring to social housing in the U.K. and the movie "I Daniel Blake", students working in groups will write a report focusing on social housing in the UK, including at least 2 citations (1500 words max). Students will have to organize a power-point presentation of 10'. For the purposes of the assignment students will also have to read the following papers:

Participation and Field work booklet 15%: Participation plays a critical role in students' evaluation, including in classroom participation and field trips. Moreover, each student should keep a record of the data collected during class visits. Fieldwork booklet includes tables and maps to be completed after each class visit. There is also room for students' independent observations. Fieldwork's material will be used in the final project and the take home exam.

Final project- Poster 15%: "Contemporary condition of former social housing enclaves in Athens". Students are going to work as interdisciplinary teams so as to create posters of A0 size, analyzing the Greek case study. Students are going to present selected representative so-cial housing types, using material collected during field work. They are also going to include at least 3 citations so as to make the appropriate connections to literature. The poster will be presented during the last class meeting.

Finals- Take Home Exam 35%: The course offers a Take Home Exam with questions relevant to the main ideas discussed during the lessons (onsite and in classroom).

Site Visits and Accessibility

- -This course requires that students walk during the 8 class visits. The walking is mostly on streets and sidewalks. During these class visits there might be limited access to bathroom facilities. In particular, students are going to attend eight field trips in the wider area of Athens, so as to visit representative examples of social housing:
- 1.Refugee blocks of flats in Alexandras Avenue, center of Athens: This social housing complex built during the 30s, is a typical example of the architectural movement of Bauhaus in Germany. Influenced by Walter's Gropius "Zeilenbau" and "Heliotropic Houses", this complex represents Modernism in Greece.
- 2.Social Housing in Kaisariani (Central Athens Sector)- a large social housing area with various architectural types (low-rise and high-rise, super blocks in the principles of the Red Vienna Period)
- 3. Typical social housing complex constructed by the Workers Housing Organization, located in Tavros
- 4. Refugee houses in Petralona (neighborhood in Athens): Stone-made refugee houses and a large Modernistic Building mark the identity of this area (Asyrmatos).
- 5. Kallithea refugee housing next to Stavros Niarchos Cultural center (Tziztifies): derelict refugee housing enclave next to a contemporary flagship project- issues of socio-spatial cohesion
- 6. Agios Sostis, Nea Smyrni, Refugee housing enclave
- 7. Refugee blocks of flats around Lycabetus hill (Gerostathi street, Skopetea street, Pitanis street).
- 8. Alternative uses to refugee housing. The case of Panormou.
- -This course also requires students to give a verbal [group, individual] presentation in front of the class as part of their assessment.

Prospective students should contact the professor before enrolling in the course if they foresee difficulties in participating in these activities.
